AN ORDINANCE AMENDING CHAPTER 197 - TOWING - OF THE CODE OF THE BOROUGH OF HAMBURG TO INCREASE CERTAIN FEES FOR TOWING COMPANY SERVICES AND TO PROVIDE FOR ADMINISTRATIVE FEE PAYABLE BY A TOWING COMPANY

ORDINANCE NO. 05-2017

BE IT ORDAINED, by the Mayor and Council of the Borough of Hamburg, in the County of Sussex, State of New Jersey, that Chapter 197 - Towing - of the Code of the Borough of Hamburg is hereby amended as follows:

1. Section 197-2: information to be provided; responsibility of towing companies.

Amend A: Add the following: towing companies shall pay an administrative fee of \$400.00 prior to be considered for inclusion on the list of available towing companies.

- 2. Amend Section 197-4 Service rates; complaints; penalties; appeal as follows:
 - B (1) (a) days {1} first mile or less: \$125.00
 - B (1) (a) days {2} each additional mile: \$4.00
 - B (1) (b) nights, week-ends and New Jersey state holidays:
 - {1} first mile or less \$150.00
 - {2} each additional mile \$4.00
- 3. Amend Section 197-4 (B) (2) (a) and (b) Delete and provide in lieu thereof the following:

Inside building and outdoor secured: \$50.00 per day.

- 4. Amend Section 197-4 B (2) (c): delete and provide in lieu thereof the following provisions:
 - {1} Winching Services. There will be a charge of \$75.00 per 30 minutes up to a maximum of \$250.00

Charges shall be in 30 minute increments.

- {2} Waiting Time: \$65.00 per hour per truck for any part of an hour.
- {3} Car Covering: \$25.00.
- (4) Roadway Cleanup: \$50.00 per half hour up to a maximum Charge of \$150.00

Charges shall be in 30 minutes increments.

- {5} Administrative Fee \$40.00.
- {6} Yard Fee \$50.00.
- 5. Any ordinance, or part thereof, inconsistent with the provisions herein is hereby repealed.
- 6. This ordinance is deemed severable, and in the event any part hereof is deem or declared invalid for whatsoever reason by a Court of competent jurisdiction, the remainder of the Ordinance shall remain in full force and effect.
- 7. This ordinance shall take effect upon passage and publication as provided by law.
