AN ORDINANCE AMENDING CHAPTER 209 - WATER - OF THE CODE OF THE BOROUGH OF HAMBURG COUNTY OF SUSSEX, STATE OF NEW JERSEY INCREASING THE SHUTOFF/TURN ON SERVICE FEE, THE TURNOFF FEE AND CHAPTER 164 - SEWERS - TO INCREASE SERVICE RESTORATION FEE AND CHARGES AND FEES FOR CONNECTION AND FOR USER FEES.

## **ORDINANCE #04-2021**

BE IT ORDAINED, by the Mayor and Council of the Borough of Hamburg, in the County of Sussex, State of New Jersey, that Chapter 209 - WATER and Chapter 164 - SEWERS of the Code of the Borough of Hamburg, is amended as follows:

- 1. Chapter 209-8 D is amended to provide that the shutoff/turn-on service fee shall be \$100.00.
- 2. Chapter <u>209-8 K</u> is amended to provide that the turnoff fee shall be \$100.00
- 3. Chapter <u>164-64 A</u> is amended to provide for a charge of \$197.82 per quarter for equivalent single-family dwelling (units EDU) effective February 1, 2021.
  - 4. Chapter 164-64 B is amended to provide that the charge for equivalent unit shall be \$182.82 per quarter effective February 1, 2021.
  - 5. Chapter 164-67 A is amended to provide for service restoration fee of \$100.00.
- 6. This Ordinance is deemed separable. If any part is declared invalid by a Court of competent jurisdiction, the rest and remainder shall remain in full force and effect.
  - 7. This ordinance shall take effect upon passage and publication as provided by law.
