ROAD OPENING PERMIT APPLICATION

BOROUGH USE ONLY!

Any permit may be revoked by the Borough Engineer after notice to the applicant for:

- (1) Violation of any condition of the permit or of any provisions of this article.
- (2) Violation of any provision of any other applicable ordinance or law relating to the work.
- (3) Existence of any condition or the doing of any act constituting or creating a nuisance or endangering the lives or properties of others.

(Hamburg Borough Ordinance §183-6)

The permit shall not be approved until a bond, the amount to be determined per Hamburg Borough Ordinance §183-3, has been posted with the Borough. Said bond to be released two (2) years from the date of completion upon certification by the Borough Engineer or such other officer appointed for that purpose that the work has been properly performed and that the restoration of the site has been maintained for two (2) years from the completion thereof and is in acceptable condition. Borough of Hamburg Ordinance § 183-4 - Expiration of permits.

Every permit shall expire at the end of the period of time which shall be set out in the permit. If the applicant shall be unable to commence or complete the work within the specified time, he/she shall, prior to expiration of the permit, present in writing to the Borough Clerk and Borough Engineer a request for a specified extension of time, setting forth therein the reasons for the requested extension. If such an extension is necessary and not contrary to the public interest, the applicant may be granted additional time for the commencement or completion of the work by the Mayor and Council after approval of the Borough Engineer.
