Chairwoman Adams advises that the "tick" kit that the county provided last year was great and would like to get more if possible, Denise from the county will look into it. The town will look at what was left from last year as far as giveaways.

Board member Sweeney discusses the app she has called 'ring" it makes the public aware of various things, one being any bear siting. She advised that to date there have been 3 siting in the area which she has received notification of through this app.

Members question work they are seeing being done by the Gingerbread Castle. There is a new owner who has been cleaning the area up but to date no knowledge of any future project for the area.

Council liaison Sena attended various meeting Wallkill Valley Municipal Drug Alliance, Hidden in Plain Site. All addressing the issue of drug use. Narcon is now available at the local drug stores without a RX for family who feel the need to have it on hand. Presently Police and Health Care members will administer.
