

Borough of Hamburg
Board of Public Works Meeting Minutes
April 10, 2024

Call to Order/Statement of Certification: In accordance with the open Public Meeting Act, with regard to notices, the regularly scheduled meeting of the Hamburg Board of Public Works was hereby called to order at 7:00 p.m.

Vice Chairman Marino invited all those present to participate in the flag salute.

Roll call: Vinnie Busted, Pat Berado, Mayor Krasnomowitz, Paul Marino, John Moeckel, John Haig (7:02 p.m.), John Perry, Alec Yanish, Regina Flammer and Erica Vigliorolo, PE of Mott MacDonald were in attendance. Chairman Garrett was not in attendance.

Minutes: A motion is made by Busted, second by Moeckel to approve the minutes of the March 13, 2024 meeting with all others members in favor.

Individual Cases: Regina Flammer discusses the payment history for 29 Circle Drive. She informs the Board that the resident of 29 Circle Drive has intended to attend this meeting but was unable to due to a car accident. A payment plan was proposed which would result in an automatic turnoff if a payment is missed. Haig added that the resident had delinquent payments last year and mentioned that her husband was disabled.

Flammer has 625 notices prepared to send out on April 12, 2024 if payment is not received. She discusses the timing of the notices and the turnoffs in relation to the Board's next meeting on May 15, 2024. Discussion continues on delinquent accounts and matching meeting dates to turnoff dates.

Mayor Krasnomowitz suggests focusing on the accounts that are more than two months delinquent. Haig suggests monthly billing.

At 7:20 p.m., Flammer left the meeting and a motion was made by Busted, second by Berado to open to John Perry with all others in favor.

Perry updates the Board on the following:

There is a leaking check valve on Booster Pump Station 2.

Well 1A should be back on line within the next two months.

Perry discusses the lead water line notice response. He will enter additional information for the condo customers.

Continued discussion on the water meter reading issues with Verizon. Yanish has end units with boosters for several carriers. Marino's house will be the testing location to determine whether the service will allow the reading on the inside or outside wall.

Haig indicates that the paving of Limekiln Road has not occurred and provides an update about the washouts on the sides of the roads. Vigliorolo will discuss compacting with the contractor.

Brief discussion on service laterals and determining responsibility.

Brief discussion on The Woods at Hamburg including the fire suppression pipes and the turning radius. Mayor indicated that the fire expert was supposed to provide correspondence regarding the turning radius.

Brief discussion on the surge protectors approved by Council for the booster station and potential to install additional surge protectors.

Discussion on the clean out for the shut offs. Haig suggests TAM Enterprises and Yanish suggests an alternate company that was less expensive (\$2,200 per day).


Haig discusses the Pennyrock leak issue. Yanish needs maps for valves and lines. Mayor questions whether there are any grants for leak detection program. Perry will look into any possible grants.
