

**Borough of Hamburg
Board of Public Works Meeting Minutes
June 11, 2025**

Call to Order/Statement of Certification: In accordance with the open Public Meeting Act, with regard to notices, the regularly scheduled meeting of the Hamburg Board of Public Works was hereby called to order at 7:00 p.m.

Vice Chairman Marino invited all those present to participate in the flag salute.

Roll call: Pat Berado, Vinnie Busteed, Mayor Krasnomowitz, Paul Marino, John Perry and Paul Ferriero, PE of Boswell Engineering were in attendance. Chairman Garrett, John Moeckel, John Haig, Regina Flammer and Alec Yanish were not in attendance.

Minutes: A motion is made by Berado, second by Busteed to approve the minutes of the May 14, 2025 Regular Meeting with all others members in favor.

Individual Cases: Perry informs the Board that the invoice in the amount of \$266.56 from C&F Plumbing for plumbing services was related to costs incurred by the resident at 25 Oak Point Drive after the Road Department inadvertently turned off their water service rather than the neighbor next door. A motion was made by Busteed, second by Berado with all other Board members in favor of paying the invoice resulting from the Borough's error.

Old Business/New Business: Regina Flammer is not in attendance to provide updates on delinquent accounts/sewer billing and the request to add detail to the water/sewer billing. Perry adds that it was his understanding that a significant number of accounts were paid after the May 20th turn offs.

A motion is made at 7:04 p.m. by Mayor Krasnomowitz, second by Berado to open the meeting to the Board professionals with all others in favor.

Engineer/Water Superintendent Report: Perry discusses the Well #3 UCMR5 results and the Sussex County reports regarding flows.

John Ruschke, PE of Mott MacDonald provided Perry with copies of bid specifications for line replacement. He will speak with Giselle Diaz, PE of Boswell Engineering about the bid specifications.

Perry got permission to turn on the well for sampling. He should know before the next meeting whether the system could be bypassed.

Perry discusses Subsurface Instruments AML Pro (\$7,913.26) and Schonstedt's MPX-Rex (\$4,975.49) which comes with a metal detector. Ferriero recommends having a demonstration to determine which equipment to invest in. The Board will carry the determination on the quotes to the July Board meeting.

Perry discusses the storm camera for sewer lines (\$565.00). Motion is made by Berado, second by Busted to recommend the purchase of the storm camera to the Mayor and Council with all members in favor.

Paul Ferriero, PE of Boswell Engineering introduces himself to the Board. He discusses the road project grants and suggests that the Borough not use co-op for projects since the Borough would have more control over construction going out to bid. He will prepare bid plans and specifications and get them approved by DOT for 2024 and 2025 paving projects. Paving of the pickleball court could be added as a separate item.

Public Portion: A motion is made at 7:25 p.m. by Busted, second Berado to open to the public with all others in favor.

Tony Saliba of Holly Drive discusses the sewage smell off Orchard Avenue. Board discussion on the smell which seems to be noticeable on Tuesday nights. Mayor discusses SCMUA upgrades to the system.

Vinnie Busted will be relocating and resigning from the Board. The Board thanks Busted for his years of service as a member of the Board of Public Works.

A motion is made at 7:27 p.m. by Berado, second Busted to close the meeting to the public with all members in favor.

Adjourn: At 7:27 p.m., a motion is made to adjourn by Berado, second by Busted with all others in favor.
