Mayor Marino reads a resolution for the record enforcing the Governor's Executive Order temporarily permitting outside dining for food and alcoholic beverage establishments and providing for a temporary use permit from the Borough after an inspection by the Borough's zoning officer and police department of the outdoor areas of the Borough's food establishments. In accordance with SR 2020-10, restaurants with a liquor license must submit the COVID-19 Expansion Permit to the State of New Jersey Division of Alcoholic Beverage Control. This temporary use permit shall continue through November or as decided by the State of new Jersey.

There will be no fees associated with the permit. Borough ordinance will be enforced with respect to the hours of operation.

A motion is made by Krasnomowitz, second by Villagomez to approve the resolution with all others in favor including Haig, Hall, Harby, Krasnowmowitz, Mayor Marino, Tempe, Villagomez, Roberts, Banta and Watts.
