CASH MANAGEMENT PLAN

BOROUGH OF HAMBURG 2010 Cash Management Plan Resolution # 2010 - 01

WHEREAS it is in the best interest of the Borough of Hamburg to earn additional revenue through the investment and prudent management of its cash receipts; and

WHEREAS P.L. 1983, Chapter 8, approved January 18, 1983 is an act concerning the Local Fiscal Affairs Law and amends N.J.S.A. 40A:5-2 and N.J.S.A. 40A:5-14; and

WHEREAS this requires that each local unit shall adopt a cash management plan.

NOW, THEREFORE, BE IT RESOLVED, that the following shall constitute the Cash Management Plan for the Borough and the Treasurer shall deposit and manage its funds pursuant to this plan:

Definitions

- 1. Treasurer shall mean the Treasurer of the Borough of Hamburg
- 2. Fiscal Year shall mean the twelve-month period ending December thirty-one.
- 3. Cash Management Plan shall mean that plan as approved by resolution.

Designation of Depositories

At least once each fiscal year the governing body shall by resolution designate the depositories for the Borough of Hamburg in accordance with the N.J.S.A. 40A:5-14.

Audit Requirement

1. The Cash Management Plan shall be subject to the annual audit conducted pursuant to N.J.S.A. 40A:5-4.

Authority to Invest

1. The governing body shall pass a resolution at its first meeting of the fiscal year designating the Borough official(s) who shall make and be responsible for municipal deposits and investments.

Investment Instruments

1. The Treasurer shall invest at his discretion in any investment instrument as approved by the State of New Jersey in accordance with N.J.S.A. 40A:5-15.1.

Records and Reports

- 1. The Treasurer shall report all investments in accordance with N.J.S.A. 40A:5-15.2.
- 2. At a minimum the Treasurer shall:
 - a. Keep a record of all investments.
- b. Keep a cash portion record which reveals, on a daily basis, the status of the cash in its bank accounts.
 - c. Confirm investments with the governing body at the next regularly scheduled meeting.
- d. Report monthly to the governing body as to the status of cash balances in bank accounts, revenue collection, interest rates, and interest earned.

Cash Flow

- 1. The Treasurer shall ensure that the accounting system provides regular information concerning the cash position and investment performance.
- 2. All moneys, shall be turned over to the Treasurer and deposited in accordance with N.J.S.A. 40A:5-15.
- 3. The Treasurer is authorized and directed to invest surplus funds of the Borough of Hamburg as the availability of the funds permit. In addition, it shall be the responsibility of the Treasurer to minimize the possibility of idle cash by depositing the monies in interest bearing accounts wherever practical and in the best interest of the Borough of Hamburg.
- 4. The Treasurer shall ensure that funds are borrowed for Capital Projects in a timely fashion.

ATTORNEY HOUR:

Attorney Clemack questioned Councilman Krasnomowitz regarding Section 10, C – Liability Insurance, but after discussion, there is a waiver that can be obtained from the carrier to cover this. Mayor Marino stated that this is already being done with Fire and EMS; he also said that the County is putting a document into place for a service that is already being done. Councilman Law questioned the Public Works Dept. and was answered that they also are already doing the same with working with the other Public Works Depts, storm clean-up, etc.

A letter was sent to the County and adjoining towns to see about the interest as Mayor Marino stated that this magnitude of a project would not be feasible for Hamburg to do alone.

1. Sussex County Economic Development Partnership – EDP 2010 Investment Council is in receipt of a request from the Sussex County Economic Development Partnership for a donation.

After clarification from the CFO, motion by Councilman Kelly, seconded by Councilwoman Oehler to make a "Bronze Investment" donation of \$200.00 a year for three (3) years. This is the 2nd year of our commitment. All in favor.

- 2.& 3. Discharge of Mortgage Block 31 Lot 7; and Discharge of Mortgage Block 21 Lot 18 Mayor Marino presented for approval a Discharge of Mortgage Block 31 Lot 7 and Block 21 Lot 18, stating that these were from the rehabilitation program with the Small Cities Grant. - 4. Mayor Marino reported that correspondence from State of NJ DOT was received regarding the signage for "engine braking" stating that we could not put up Borough signs enforcing the ordinance. We would also need signs posted should any matter ever go to court.

2. CONSTRUCTION DEPARTMENT

Construction report November 2009

According to the construction report received for November 2009, 14 permits were issued, 0 certificate of occupancy, 10 certificates of approval and \$1764.00 in fees were collected. Councilman Krasnomowitz brought to the Council's attention that in November 2008, a total of \$180,525.00 in total costs were collected, compared to this years' of \$51,664.00.

Construction report December 2009

According to the construction report received for December 2009, 10 permits were issued, 3 certificates of occupancy, 19 certificates of approval and \$1154.00 in fees were collected.

Councilman Krasnomowitz stated that from January – November, the Borough collected \$31,683.00 in fees for permits. According to our contract with Hardyston, we are responsible to pay a yearly shared services fee of \$52,000. This makes our cost to the Borough \$19, 163.00. Councilman Krasnomowitz said that this makes it very beneficial to keep it as is as opposed to paying for an entire department.

3. LAND USE BOARD

Monday, January 11th at 7:30 PM is the re-organization meeting for Land Use.

4. INSURANCE

The 2010 Fund Year Assessment and Coverage, which is the cost for our property, is at \$114,490.00 for the coming year. Changes show that the coverage is enhanced for the Borough and is the 2nd year of our three year commitment.

COUNCILMAN BARR

** Councilman Barr informed the Council that Fire / EMS did not go over budget for the 2009 year and he commended them for their hard work in that area.

1. BOARD OF EDUCATION

Councilman Barr brought up the correspondence received from the Hamburg School Administrator regarding possible shared services agreement for a maintenance agreement on school property from April 1 – November 1. Councilman Barr stated that the Road Dept. personnel are short-handed now but will speak to the school. He also believes that the school wants this service done for free. Councilman Krasnomowitz stated that this would have to be a shared services agreement.

The request for 2010 Yearbook contribution from Hamburg Elementary School will be tabled until the February meeting pending further information regarding the donation amount.

2. ROAD DEPARTMENT

Councilman Barr said that Mike Schneider has nine (9) days left; has not taken time off as he does not have a 2nd in command to take over when he is off. Mr. Schneider asked if he could be reimbursed and appoint someone in charge. Councilman Sena said to let him carry the nine days. Councilman Barr suggested giving him an assistant with a \$1.00 stipend. Councilman Kelly said to just leave it unfulfilled and Councilman Krasnomowitz said that Mr. Schneider should possibly delegate the work load differently. Council members need to find out how the union contract reads. Motion by Councilman Barr, seconded by Councilman Kelly to allow Mike Schneider to carry the remaining days from 2009 to 2010, with this being the last year he is able to do so. All in favor.

PUBLIC PORTION:

Sheila Frayko – Board of Ed – said that at the Board of Ed meeting, snow plowing was discussed but not lawn maintenance.
