Heritage Lakes Pump Station Improvements Project - Letter of Protest 2.

Attorney Clemack advised that at the time that this project went out to bid, Liberty Construction, who was the low bidder for the project, was registered under Liberty Electric, a fictitious name, and put this name on the bid documents. One of the other bidders was protesting the bid, but once Attorney Clemack looked into this matter, everything was cleared up and Liberty Construction can be awarded the bid.

Tax Assessor 3.

Attorney Clemack discussed the length that the tax assessor has been out on illness and is concerned that although it is a temporary basis, tax appeals may be coming in, so in all fairness to the residents, the Council needs to be aware of the situation. After some discussion, motion by Councilman Krasnomowitz, seconded by Councilman Law that the Mayor is authorized to enter into negotiations should it be necessary with another person for temporary help at a rate of compensation to be discussed. ENGINEERING:

Proposed Engineering Services for NJ Environmental Infrastructure Financing Program - Falcon Ridge Sewer Interconnection, Heritage Lakes Pump Station Rehabilitation, and Orchard Street Drainage.

2011 Municipal Aid Award – Urban Street Road Improvements 3.

Mr. Ruschke stated that Hamburg received \$150,000.00 from the NJ Dept. of Transportation 2011 Municipal Aid Program for the 2011 Road Resurfacing project. Roads to be included in the project will be: Gov. Haines, Urban Street, Prince Street, Limekiln, and Wishing Well Road. There is no date as to when the work will start.

EEECBG - Energy Efficiency & Conservation Block Grant 4.

Mr. Ruschke stated that an application was submitted and an audit was performed on the buildings to upgrade them to be more energy efficient, up to \$50,000.00. This would include the Municipal Building, Court House, Police Station, DPW, and Pump Station. Donnelly Energy Solutions is the contractor that would be performing the work, which would include lights and fixtures, how water heaters, and furnace.

Motion by Councilman Kelly, seconded by Councilman Barr to accept the EEECBG grant pending CFO certification of funds thru the grant money. All in favor.

Concession Stand – Rec Fields 5.

The shell of the stand is up with the roof and shingles on. Mr. Ruschke stated that we are in a good position with the time frame. The contractor right now is just waiting for the weather to break so that he can begin work on it again.

MAYOR'S AGENDA:

Proclamation: Read Across America 1.

Motion by Councilman Barr, seconded by Councilwoman Oehler to endorse the Read Across America Proclamation to be conducted on March 2, 2011. All in favor.

Main Street - Parking

Council discussed the lack of parking on Main Street, the results of a conversation that Mayor Marino had with Ms. Bridget Walsh, owner of Wicker Plus on Main Street, plus the owner of apartments above the store.

Motion by Councilman Krasnomowitz, seconded by Councilman Kelly to open the meeting with regards to this matter only. All in favor.

Ms. Bridget Walsh stated that she has been the owner since 1978 and never had a problem until the State came in and redid the intersection, taking property by condemnation from her, at the same time guaranteeing that she would have parking. To date that has not happened. Her tenants have no where to park, let alone the difficulty it is for customers. She implored the Council to allow the usage of the municipal spaces for her tenants, with a permit usage only. Ms. Walsh stated that she is concerned about further renting out her unoccupied unit since her new tenant has received a parking ticket due to lack of parking.

Motion by Councilman Barr, seconded by Councilman Law to close to the public. All in favor.

Council discussed different ways to handle the situation. A committee made up of Council members Kelly and Barr, and Mayor Marino will look into the situation further and report back to the Council. They will also look at the parking at the Fire Dept., EMS and Court house buildings and also the signage around those areas to see what could be done to help rectify the situation. Councilman Law asked if we could hold off on issuing tickets and Mayor Marino replied that if would be up to Chief Wright.

Mayor Marino stated that there are software issues with the key fob system that has been installed in our buildings. At the present time, Sid Crum is in charge of inputting the key fobs and changing the time / dates of the doors. Mayor Marino would like to have Mr. Crum train Melissa Velez and keep it in house.

Police Monthly report for January 2011

The January monthly report for the Police Department showed 1057 calls of service, including 149 investigative reports, 13 arrests, 8 motor vehicle accidents, and 132 motor vehicle summonses issued.

Councilman Sena presented a letter from Ken Kievit of the Sussex County Sheriff's Crime Stoppers, Inc. requesting a donation. Mayor Marino added that he believed it would be a good organization in which to make a donation.

BOARD OF HEALTH

Councilman Sena stated that the Board of Health Re-Organization meeting was finally held, with Linda Adams as Chairwoman and Dr. Peter Karas as Vice-Chairman. Unfortunately as the meeting was held during the day, Councilman Sena was not able to attend. He also stated that the Board is thinking of having daytime meetings if everyone on that Board can meet then, but he will not be able to attend. Mayor Marino asked Councilwoman Oehler if she would be willing to be the liaison to the Board should that happen and she stated yes. Mayor Marino will advise.

COUNCILMAN KELLY:

BUILDING AND GROUNDS

Chief Wright approached Councilman Kelly about putting in a key fob system in the back entrance of the Police Dept. This system would match with the school, have tracking software and would cost approximately \$1200.00. Council members discuss looking into getting a cost estimate for the municipal building also.

BOARD OF PUBLIC WORKS

There was a major water main break on Rt. 23 between Winding Brook and Edsall Street. As this is the 2nd one and in speaking with Water Superintendent Jerry Kastner, Road Dept. Foreman Mike Schneider would like to see if a major repair could be done. Mr. Ruschke will speak to Mr. Kastner and Mr. Schneider and put some numbers together for renovating that part of the system.

OEM / EMS LIASON 3.

Councilwoman Oehler also discussed the parking at the EMS building and the lack of it for the crew that responds to a call and wondered what steps could be taken to correct the situation. She also

stated that the roof in the EMS building is leaking again.

FIRE COMMISSIONER

Councilman Law presented the Council with a list of tentative parade dates the Fire Department would like to attend: St. Baldrick's Parade on Saturday, March 19th, Memorial Day Parade on May 30th, Port Jervis Parade on July 9th, (a truck plus the Chief's car will be used) and the County Parade on Oct 1st (rain date October 2nd).

CONSTRUCTION DEPARTMENT

Councilman Krasnomowitz stated the correspondence was received from Hardyston Township regarding Inter-Local Agreement for Construction Services in which they would like to change the current contract to be consistent with their other inter-local contracts. Basically this would change our current contract from a 4% increase and reduce it to 2 $\frac{1}{2}$ %.

Mayor Marino feels that Councilman Krasnomowitz does have some valid points but that we should also consider what our consultants advise us to do. Councilman Barr said that we should go with the recommendation of

our professionals and that would be to list it as the parsonage and church as one designation. Councilman Kelly agreed with the consultants' recommendation also.
