NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council advises the public that formal action may be taken later this evening on the matters discussed in closed session or on other matter.

Motion by Councilman Krasnomowitz, seconded by Councilman Law to accept the resolution as offered. All in favor.

ENGINEERING:

Recreation Fields 1.

Mr. Ruschke informed the Council that the work on the concession stand is substantially complete with some fixtures to finish. The contractor wants to do some site work, including some grading and paving, but the weather is not cooperating. He would like the top soil and seed down by Memorial Day. Mr. Ruschke asks of the Council their advice of installing gutters on the structure at a cost of approximately \$3000.00. As it stands now, the rain would fall right at the edge of the concrete around the stand so he does not feel that it would be necessary to spend the money. Council agreed. Councilman Sena asked about the steepness of the walking path by the soccer field and was concerned about kids with skates and skateboards, etc. going off the path and wanted to know about putting up a rail or fence for protection. After some discussion, Mr. Ruschke will look into putting up a fence in that section. Councilman Kelly inquired about the trees that were going to line the driveway coming into the park. Mr. Ruschke stated that we used the money to widen the path. Mayor Marino said that he received information that everything had to be ADA compliant and asked Mr. Ruschke if we are impacted by that. He replied not really because of the topography of the land and the building is not affected by it either.

Falcon Ridge - NJEIT Interconnection Project 2.

Work on the Board of Education property has been started. Work on tunneling under the railroad should start next week and will take around one week to complete. The project could end up

costing a few dollars more due to a mark-out being wrong, so more steel had to be used to complete the project.

3. Heritage Lakes-NJEIT Project

Mr. Ruschke informed the Council that the shop drawings have been submitted and approved.

4. Orchard Street-NJEIT Project

Mr. Ruschke said that the road has been marked out and unfortunately, the contractor, John Garcia Construction always starts late but does get the job done.

Mr. Ruschke also said that the Board of Education has been calling him as they would like to coordinate the use of this contractor to do some repairs for them as we did when we did the project on Summit and Circle. Mayor Marino said that he would like to do the section of Bank Street and that possibly use this contractor for that. Mr. Ruschke suggested adding it to the DOT grant that we are receiving.

5. Tax Maps

Mr. Ruschke brought up the situation of our tax maps being entirely updated for about 15 years. He stated that there has been no interaction between himself and the tax assessor to comply. Mr. Ruschke does have the tax maps on the computer but they are not to State code and there is not documentation to all properties in town for the information to correlate to. He has spoken to a surveyor and it would be a minimum of \$12,000.00 to get the tax maps to where they should be. Council members asked if perhaps since the County is requesting the re-evaluation that there would be some financial assistance for this but Mr. Ruschke stated that there is not. Whoever does do the re-evaluation for the town needs to be made aware of this information as it will make a difference. Mr. Ruschke is looking for guidance from the Council as to how to proceed from this point. After Council discussion, Attorney Clemack, Mayor Marino, Mr. Ruschke, and John Dyksen will conference call to resolve the situation.

MAYOR'S AGENDA:

1. Kevin Keil – Application for employment

Mayor Marino said he wanted to talk to Chief Wright about this application first.

2. From Sussex County Agreement and Sample Ordinance for Interlocal Fire Official Discussed in Executive Session

3. New Jersey Conference of Mayors Update

Mayor Marino spoke to Cindy Randazzo of the State Dept. regarding the T-Mobile tower at the rec fields and us needing a waiver from Green Acres to construct the tower and wondered what we needed to do since we are not seeing any movement at all. Mayor Marino did get the phone number of the Lt. Governor so he said he would call him.

Key Fobs

Mayor Marino said he would be in touch with Spark-Tech in Dover about our system and have them come out and see what is going on with it.

Foley

Information came out for doing an emissions check on state vehicles and Mayor Marino said that Mike Schneider handled the situation.

Cost Recovery - Fire / EMS Motor Vehicles

Mayor Marino said that the information he received about this goes according to NIFRA reports; he requested more information to be sent.

COMMITTEE REPORTS:

COUNCILMAN SENA

1. FINANCE / TAX DEPARTMENT

The Tax Collector's report for March 2011 showed a total of \$304,409.85 being collected.

2. POLICE COMMISSIONER

Police Monthly report for April 2011

The April monthly report for the Police Department showed 1100 calls of service, including 167 investigative reports, 30 arrests, 14 motor vehicle accidents, and 160 motor vehicle summonses issued.

Councilman Sena discussed the key fob situation and said that Abcode has been contacted to evaluate and give a proposal to have the system work again. Mike Schneider has replaced the locks so the buildings are secure in the meantime.

With regards to the POSHA inspection report that was done on the Police station, the repairs have been completed.

COUNCILMAN KELLY:

BUILDING AND GROUNDS

Motion by Councilman Kelly, seconded by Councilwoman Oehler to open the meeting to Road Dept. Foreman Mike Schneider. All in favor.

Council discussed with Mr. Schneider the work that needs to be done on Summit by the water tanks with the clearing of debris that has washed out and is covering the back and side of a tank. Mr. Schneider stated that the Borough will be able to borrow a small machine from the school to do the clean-up. Council also discussed a retaining wall to prevent this from happening again and Mr. Ruschke believed this was not necessary at this time.

Motion by Councilman Kelly, seconded by Councilman Law to close to Mr. Schneider. All in favor.

COUNCILWOMAN OEHLER:

1. RECREATION

Councilwoman Oehler informed the Council that the Miss Hamburg, Little Mr. / Little Miss Hamburg Contests have been scheduled for June 26^{th} at 1 PM at the Hamburg School. Hamburg Day has been scheduled for August 20^{th} with a rain date of August 21^{st} . Summer recreation will be held from July $5^{th}-22^{nd}$ and flyers have gone out for registrations.

3. OEM / EMS LIAISON

Councilwoman Oehler stated that ambulance 26/41 is still out for repair now for three weeks. There are still issues with some items and the brakes are not working now.

COUNCILMAN LAW:

1. FIRE COMMISSIONER

Council members discuss the notice from the Sussex County Board of Chosen Freeholders regarding the Certification for Rescue Squad Contribution for the Hamburg EMS Division of the Fire Dept. to receive financial assistance in the amount of \$3500.00 from the County of Sussex. Motion by Councilman Law, seconded by Councilman Krasnomowitz to accept the contribution in the amount of \$3500.00.

Discussion revolves around the issue that the money should go into the EMS budget and not into the Fire budget.

Motion by Councilman Law, seconded by Councilman Krasnomowitz to amend the motion to approve the acceptance of the contribution in the amount of \$3500.00 to go to the EMS budget. All in favor.

2. RECYCLING

A community clean-up was done with the Hamburg School with a good turn out, involving some returning high school and college students also. Quite a few bags of trash were pick-up as a result of the clean-up.

The recycling report was due May 1st, but since there were some conflicts, it will be filed within two weeks.

COUNCILMAN KRASNOMOWITZ:

1. OFFICE ADMINISTRATION

2. CONSTRUCTION DEPARTMENT

Construction Activity Report for February

Councilmember Krasnomowitz advised that there were 5 permits issued, 0 certificates of occupancy, and 10 certificates of approvals with a total of \$995.00 collected in fees for the month of February.

Construction Activity Report for March

Councilmember Krasnomowitz advised that there were 11 permits issued, 0 certificates of occupancy, and 14 certificates of approvals with a total of \$1848.00 collected in fees for the month of March.

3. LAND USE BOARD

Mr. Patel received his approval for the gas station application after making some changes.

4. INSURANCE

The Mayor and Council received notification that Hale Insurance Company will now be known as HUB International Northeast. Councilman Krasnomowitz has some concerns about how this will now work so he is checking into other options at this time.

5. RECREATION COMMITTEE

Councilman Krasnomowitz informed the Council that he has had second requests about the use of the fields. He stated that nothing has been decided about when we are allowing the use of the fields, etc. Mr. Ruschke stated that although the contractor is still working there, it is very limiting work so we could open the park if we wanted to. Mayor Marino said that he would like to wait until after the grand opening of the fields, then opening it up to residents in June and the to others in the Fall. Council agreed.

COUNCILMAN BARR

Report given by Mayor Marino

1. BOARD OF EDUCATION

The Board of Education meeting focused on the budget and checking into the installation of solar panels on the school roof.

2. ROAD DEPARTMENT

Estimates for Tractor with cutting head and back hoe from Bassani Power Equipment and Nolts Power Equipment.

PUBLIC PORTION:

Motion by Councilman Kelly, seconded by Councilman Law to open the meeting to the public for any questions or comments they might have with regard to the good and welfare with the Borough. All in favor.

Police Chief Wright – Mayor Marino asked Chief Wright about the policing of the rec fields and he said his department would rely on the ordinances and any rules and regulations the Council made. He did state that he would need the ordinances in place so as to enforce anything that would come up.

Mike Schneider — Road Dept. Foreman — stated that he needed a machine to cut grass and presented the Council with two proposals, one from Nolts in the amount of \$39,800.00 and one from Bassani Power Equipment in the amount of \$37,940.00. The machine included a backhoe with attachments so it could be used for other uses that the road dept. might need it for. Upon discussion, Council suggested buying a lawnmower now and replace the tractor when needed. Mr. Schneider will get information on lawnmowers. Since the BPW is going to be submitting a 5 Year Plan, Councilman Kelly suggested getting a 5 Year Plan from each dept., with other Council members in agreement.

Motion by Councilman Krasnomowitz, seconded by Councilman Law to close to the public. All in favor.

Motion by Councilman Krasnomowitz, seconded by Councilman Law to enter into Executive Session at 8:58 PM. All in favor.

Chief Wright recommended an amendment to the ordinance to cover an early dismissal and delayed opening. Hamilton Street side is the problem; maybe doing a barricade during those few times, with a custodian in charge of this.

Motion by Councilman Law, seconded by Councilwoman Oehler to accept the resignation of William Flammer as Fire Official effective May 31, 2011. All in favor.

Hardyston and Andover Townships will be contacted to see if they are interested in the Fire Official position.

The Borough is having Memorial Day Services at North Church Cemetery at 9:15 AM and then at the monument here at Borough Hall at 9:45 AM on Monday, May 30th.
