ATTORNEY HOUR:

ENGINEERING:

Motion by Councilman Law, seconded by Councilman Sena to open to Borough Engineer John Ruschke. All in favor.

Mr. Ruschke informed the Council that the contractor for the booster station on Bank Street is starting to install and will continue into January, with the electric transfer going in tomorrow. An invoice in the amount of \$130,000.00 should be coming through for the work. The generator has already been installed and to date, there have been no change orders and no issues. Mayor Marino added there is enough money to complete the project without using funds from the 2017 budget. The 2017 funds will be used for preventive maintenance on our equipment.

Mr. Ruschke brought up the new 5 Year Plan, stating the storage tanks need to be looked at as the main one is 75 years old, possibly doing modifications on the tank as it still seems to be in good shape. The other two tanks were painted 20 years ago; divers will give an overview on the inside of those tanks. The controls of the wells in the booster station were installed 15 plus years ago and may need replacing. Mr. Ruschke stated these are smaller jockey pumps at a cost of \$50,000.00. All in all the system is running very well. Councilman Krasnomowitz asked if all three tanks were needed and Mr. Ruschke answered that it was beneficial for more, and, according to DEP regulations, if one should go down, we could take it off line while the others are still working.

The micro-paving was discussed, with Mr. Ruschke understanding that complaints were received. He stressed that it was not a structural repair for a road: the micro-paving is done, then the crack and seal and this entire process extends the life of a road. He also said the State will be looking to give out grants again in 2017 and we have not received anything for a few years so our chances should be increased. He will talk to Mike Schneider about the roads and would like to submit a DOT grant in the amount of \$100-120,000.00 as it seems that is a good amount for us to submit and receive. The grant is due by February 3, 2017. The

DEP is adopting new stormwater regulations for Tier A – Hamburg is Tier B (mapping, etc.) and Mr. Ruschke is checking into it.

Councilman Sena asked about Rt. 23 North by Winding Brook and the dip in the road, saying that when trucks go over it, the noise is horrendous. He asked if this was from a leak from a water main, but testing was done, and it is due to settlement of the pavement.

Motion by Councilman Barr, seconded by Councilman Law to open the meeting to Jerry Kastner and Mike Schneider. All in favor.

Mr. Schneider said there were no leaks in the road way and Mr. Kastner said he is doing a final report but it should be on DOT to repair. Mr. Ruschke will send DOT a letter advising them of the situation and findings.

Ms. Kays stated she hoped to see 65 years but enjoyed every moment and throughout the years there was not one child hurt and not one car accident while she was on her post.

Director Yahm presented a plaque to Detective Jeffrey Sokolowski for his Life Saving actions while responding to a call in town, resulting in saving the life of a resident. Detective Sokolowski will also receive a citation bar for his uniform. Councilman Barr presented a plaque to Detective Sokolowski on behalf of the Borough for his commitment to the Borough and his outstanding actions while responding to a medical emergency.

Patrolman Devin Gormley

Director Yahm presented a plaque to Patrolman Devin Gormley for his assistance with an attempted suicide, resulting in saving the life of a resident. Patrolman Gormley will also receive a citation bar for his uniform. Monthly report November 2016

The November 2016 monthly report for the Police Department showed 812 calls of service, including 6 arrests, 13 motor vehicle accidents, and 34 motor vehicle summonses issued (ETickets – 34, hard copies – 0).

Director Yahm stated the new weapons were in service, with all but one officer still needing to qualify on the weapons. He also needed to move the repeater once and will have to move it one more time due to the ongoing booster station project. A new work station was added at the station as a new computer was needed. Scheduling has been done on paper but will now be done on the computer at a cost of \$1000.00 a year. Director Yahm also stated there will be an overtime spike due to several investigations, all with positive results.

The Tax Collector's Report for October showed a total of \$384,127.23 being collected with the report for November 2016 showing a total of \$2,206,069.23 being collected.

Councilman Law stated that the Borough has to be notified six months in advance with a change after a certain amount of time if they are going to be taking back equipment so he will contact Ms. Smith for further information and options.
