MAYOR MARINO'S COMMENTS:

Mayor Marino started off saying last year was a difficult year with a lot of adversity adding that we could not control some things but have to correct them. He is hoping this year will be better and indicated this year we have to be more committed in working with all the departments. With regards to the Police and the OIC, the Borough has complied with all mandates that we have been given and is able to change the OIC yearly as it is a normal appointment. Sgt. George Gunderman who was appointed OIC today was the OIC when he became injured and unfortunately had to go out on disability. Mayor Marino stated he does not intend to change the OIC position continually but would like to go to a Lieutenant and Sergeant position. Then there would be no confusion about the OIC: if the Sergeant is out then the Lieutenant is the OIC and vice versa. Mayor Marino would like to see more solidarity in the dept., stating Sgt. Gunderman also with Director Yahm hired most of the officers in the dept. No one was penalized when Sgt. Gunderman returned and the OIC at the time did a tremendous job. There is no disparity going on with anyone; people take different positions at different times for different reasons and circumstances sometimes dictate that. Mayor Marino ended with wishing everyone a Happy New Year and good luck to the new officers and relayed Council support at all times.

COUNCIL COMMENTS:

Councilman Krasnomowitz

Councilman Krasnomowitz wished everyone a Happy New Year and thanked everyone for their support in electing him again for another term. He stated that the past year was a difficult year and that hopefully it was behind us. Councilman Krasnomowitz thanked all the employees for their dedication and also the volunteers as the town counts on them for the many boards.

Councilman Fitzpatrick

Councilman Fitzpatrick also thanked everyone for his election to the Council and he looked forward to a good year. He mentioned that he had big shoes to fill with taking Councilman's Barr place. His one big goal is to make Hamburg an affordable place to live.

Councilman Burd

Councilman Burd stated that this Council works hard for Hamburg; there has been some adversity but he wants to move forward.

Councilman Law

Councilman Law wished everyone a Happy New Year. He also reiterated that it was a tough year and is looking forward to a better year, stating that Hamburg has a good Police Dept. and the issues can be worked out. Councilman Law also said the Court was starting out with a new judge and prosecutor. He was also looking forward to working with the school and school kids with recycling.

Councilman Garrett

Councilman Garrett congratulated Council members Krasnomowitz and Fitzpatrick for their re-election and election as Council members. He was looking forward to taking on some new projects with Buildings and Grounds to keep costs down. The Board of Public Works is working on a new 5 Year Plan for projects and maintenance on our water / sewer system. Councilman Garrett also thanked Fire and EMS volunteers for the job they do, adding that unfortunately he will not be pulling a duty night any longer due to his job and the difficulty in functioning the next day but he will help out when he can. Councilman Garrett said the new Chief and Assistant Chief will do a great job.

Councilman Sena wished all a Happy New Year and thanked Councilman Barr for his years of service and that he will be missed. He also agreed that last year was a bad year, saying we will work hard to minimize this, and we will have to work through it.
