Adequate notice of this meeting has been provided to the public and the press January 5, 2018 by delivering to the New Jersey Herald and the Sunday Herald and posting at the Municipal Building a copy of the "Annual Notice of Meetings" pursuant the provisions of the "Open Public Meetings Act".

Mayor Marino briefly discusses the progress being done on the program for the "Special Post Card; Date meets Zip Code" Wilcox Press is printing out the post cards, there will be a special stamp made that will be run through the post office machine to cancel the stamp out. The cost will be covered by recreation. The sale of the cards will be \$3.00 each, upon the sale the monies will be put back in recreation and the fire department will be given some to also sell. Hoping to have them in a week or so.

### R. Krasnomowitz - Police Director Position

Councilmember Krasnomowitz advises that the appointment for the police director will be coming up at the July 1, 2019 Mayor and Council meeting. He advises that when hired his salary was scaled back from the previous employee. The committee feels that he has done an outstanding job with working with the police department, grants, and recent dispatch agreement and would like to see his pay increase from \$30,000 to \$35,000 annually. Along with the increase in salary the position will expand its role to include that of Public Safety Liaison and working with the Fire Chief, OEM and EMS which Mr. Postorino has extensive experience in. Mayor would like to have a separate resolution for the July meeting for this Public Safety Liaison position as opposed to changing the existing Police Director Ordinance to incorporate this new title.

Police Director thanks the council and advises that he feels it is more formal that he be given the separate title. The resolution and appointment will be done at the July 1, 2019 meeting.

# Request from Fire Department to authorize the transfer of approval from Social Affairs Permit (Corn Hole Tournament scheduled but cancelled for June 15, 2019 to application for Social Affairs Permit Clambake (August 24, 2019 1-p.m.)

Mayor advises that the Hamburg Fire Department has requested that their application for the June 15, 2019 Corn Hole Tournament be transferred to the upcoming Clambake scheduled for August 24, 2019. The June 15<sup>th</sup> Corn Hole Tournament has been cancelled. Clerk was advised by fire department that the State wants a letter showing formal action by the governing body authorizing this transfer.
