Attorney Clemack relayed to the Council that he would like to hold off on this until we hear from other carriers as Planet Network wants unrestricted rights. Councilmember Krasnomowitz disagreed, stating that this would be a positive addition to Sussex County; a business improvement which is lacking here. They are running it in Newton now and Councilmember Krasnomowitz wonders why we could not give other carriers

the rights also. In the correspondence, it is mentioned that it is available to have someone come and give us specifics on it. Councilmember Krasnomowitz will reach out and get more information about it.

Monthly report June 2019

The June 2019 monthly report for the Police Department showed 789 calls of service, including 3 arrests, 15 motor vehicle accidents, 81 motor vehicle stops, and 104 motor vehicle summonses issued.

Mr. Postorino thanked all that were involved in helping with the 7-11 incident. He attended a meeting on Friday with Sparta for an email-chain-radio testing. October 1st at 8 am we will be going live with them. There will be a Drive Sober or Get Pulled Over campaign taking place in the fall. Mr. Postorino is working on two grants: Kem Trucks in the amount of \$7500.00 for haz mat equipment and Fire House Subs.

The newly appointed officers started today and will be doing 4-6 months of training.

3. CONSTRUCTION DEPARTMENT

Monthly report May 2019

The monthly report for May showed there were 18 permits issued, 0 certificates of occupancy, and 13 certificates of approvals with a total of \$2283.00 collected in fees for the month of May.

4. LAND USE BOARD / ZONING

Monthly report May 2019

Report as submitted by Zoning Officer.

Request to allow for DPW to provide property maintenance for 50 Hillside Drive

Mr. Drossell submitted a request to deal with property maintenance code violations, asking for help from the Road Dept. to help maintain the properties. Some of the Notice of Violations go unanswered and as such, the code violation continues to grow, annoying the surrounding properties. He is also asking to do so without waiting for Council consent.

Motion by Councilmember Krasnomowitz, seconded by Councilmember Law that the Zoning Officer can

contact the Road Dept. for their help with property maintenance issues without Council approval. A charge for their services will be placed on the property. All Councilmembers present in favor.

5. INSURANCE

Councilmember Krasnomowitz stated there is a great deal of "ransom fees" going on with computers nowadays and relayed the importance of not opening up any email that you do not recognize. He added that everything here is backed up.

2. RECREATION COMMISSION

Councilmember Oehler relayed the names of the Hamburg Contests winners for 2019: Miss Hamburg is Mikaela Crowell, Little Mr. is Dwight Landrud, and Little Miss is Madelyn Dick.

The Ice Cream Social was held and very successful with many repeat attendees. Tom Gardner did a wonderful job with the music.

Councilmember Oehler stated the Littell Center's future is unsure as the military has the building up for sale.

COUNCILMEMBER BURD

2. FIRE COMMISSIONER / EMS

May 2019 EMS report

There were 18 EMS calls for St. Clares and 22 EMS calls for the town.

Councilmember Burd mentioned the EMS captain is requesting 2 tablets for the rigs so that members can record and submit their reports while on the rig. Tablets run between \$100.00 - \$150.00 per tablet. The t-shirts were brought up; some received them while others did not.

4. BOARD OF EDUCATION

Councilmember Burd said he could not get any answers regarding the charter school questions that were brought up at last month's meeting but he will keep working on it.

1. BUILDING AND GROUNDS

The fitness trail at the rec fields is in and Councilmember Garrett encouraged members to see it. Cintas – Uniform provider - DPW

Cintas will provide uniforms for the DPW workers and mats for the buildings at a monthly cost of \$117.76. Councilmember Garrett stated this is approximately a \$3000.00 savings over the current carrier. Motion by Councilmember Garrett, seconded by Councilmember Law to accept the weekly proposal from Cintas in the amount of \$117.76. All Councilmembers present in favor.

The bid opening for the water meters was held and now John Ruschke will review it and recommend to the Council.

4. ROAD DEPARTMENT

The tires on the back hoe will need to be replaced within the next 6 months, which will cost around \$2000.00.
