OSHA made a visit and there are certain violations Hamburg will need to address. One change Councilmember Haig is suggesting is to get rid of the DPW trailer, move EMS into the Court house and move DPW into what was the EMS side of the DPW building.

Councilmember Haig discusses the many properties that are in disarray throughout the borough, wanting to help out the property maintenance officer. When noted that he may already know about a property in question, Councilmember Haig relayed that he will get in touch with him tomorrow.

With the paving taking place on Rt. 94 and Rt. 23., Councilmember Haig relayed there are valves that need to be exercised before this happens. Alec Yanish will work with DOT and come up with a game plan. This will also require Police to be on the scene.

those of homeowners. These lines most likely can be found in older developments. Residents are also able to apply for this grant. Borough Clerk Doreen Schott is working on a survey that will be sent out to residents to find out if they have a galvanized service line from their curb stop into their home.
