There will be no movie night this year as a requirement is to obtain a License Permit. Cost is \$750.00. Councilmember Oehler is reaching out to Hardyston Township to discuss several options. Councilmember Sena discussed this year's tree lighting ceremony. Would like to see improvement in the future. The police should be available to perform road closure on Wallkill Avenue. Councilmember Oehler is aware, there were issue last year and is working with the Ladies Auxiliary along with rec for this year's lighting.

COUNCILMEMBER ENDRES

Monday, July 10, 2023 the Historic Commission and Land Use Board will be meeting jointly.

COUNCILMEMBER LAW

A memo regarding reimbursement procedures will be going out to Mayor / Council and all department heads. Reimbursements will only be provided if verification (receipt) is attached. Councilmember Law advises that governing body is in receipt of the OEM report. They were very busy, water main breaks, power outages, assist to DPW an PD. They are again applying for the 2023 grant; grant amount is \$10,000. Hamburg is 1 of 3 towns that applied, this is the 3rd year applying and is confident we will get it again.

COUNCILMEMBER HAIG

DOT will be doing road work- paving between Rt. 23 Franklin to Doc's Place in Hamburg shortly. The road department exercised valves and found one by King Cole Road that was in need of repair. Three companies were contacted, only one quote was received back from Hank Sanders in the amount of \$2,620.00 the cost does not include jack hammering if that is required, Road Supervisor advises worst case scenario for jack hammering would be \$1,500.00. This is time sensitive as paving is to begin on July 19, 2023 and the valve needs to be repaired prior. Motion by

Councilmember Haig, seconded by Councilmember Law to accept the quote from Hank Sanders with the understanding that if jack hammering is required the cost may increase. All in favor. Decal on the RT 23 Railroad Crossing Trestle will be replaced. Mr. Geddis will do the repair and the it will be arranged with the police.

All received a copy of the PEOSHA report last month, all issues have been resolved and in compliance.

Holiday Decorating Lights – Route 23 and Main Street. -2 quotes and one non-responsive quote was received. Holiday Designs - \$11,040.33, Holiday Outdoor Décor \$13,769.17 and non-responsive from Pole Mounted Holiday Decorations. Councilmember Haig advises that JCP&L will perform the hook up on the State Highway, Local Road will be done by local electrician. 20 poles are mapped as indicated in the map provided. decorations in total; 6' snowflakes for Rt 23 and 3" candles for Main Street, money will be coming from the American Rescue Plan. Mayor questions whether there is a time frame from which it will be needed to be taken down. Attorney will review, \$11,040.33 cost for Holiday Designs, \$1,200.00 Local Electrician, \$295.00 Permit fees.

Motion by Councilmembers Law, seconded by Councilmember Oehler to approve Holiday Designs in the amount of \$11,040.33. Project will include JCP&L fee \$14,000 Local Electrician fee \$1,200.00 and Permit fee \$295.00. All in favor.

COUNCILMEMBER SENA

Amendment to the Animal Control Shared Service Agreement to include Dog Census. Mayor to execute

Open Space – Recreation Grant – Green Acre Park - Matching grant received for \$50,000.00 to improve both existing courts. Councilmember Sena and Haig have been working on this grant. Bid was prepared showing basketball and pickleball. Engineer emailed both mayor and Councilmember Haig advising recommendation to include in the grant both basketball and pickleball. Councilmember Haig asked if the material is the same as that which was spoken about prior. Clerk advises that the bid was received from the engineer with instruction to publish. Councilmember Sena wants to see the council involved, the river area adjacent is a disaster, municipal park needs more to be done. Councilmember Oehler would like to see pickle ball at the recreation field and basketball at the Green Area Park. Requests meeting with the engineer so this can all be worked out.

Motion by Councilmember Oehler, seconded by Councilmember Law to see the publication of the bid can be cancelled. All in favor.

PUBLIC PORTION:

Paul Marino – Confirms with the attorney that any project brought before the council should have council vote. Confirms with Councilmember Haig that DOT and JCP&L approval – permits were granted for the Decorative Light Project. Paul Marino advises that he agrees with separating the BPW position, feels that the recreation position should have been part of the Deputy Clerk / Deputy Registrar position instead of having three positions where you had one person performing those duties. lastly, he discusses that the property will be discussed in executive session and that the plans for that property may change. He is disappointed but understands the change, the basis for the original plans was to get the police department a new building as the old one has compliance issues. He advises that the town looking to sell is a good thing as there was money already spent that can be recouped. He thanks the Mayor for the BPW appointment
