Be it resolved by the Council Members of the Borough of Hamburg, County of Sussex that the budget hereinbefore set forth is hereby adopted and shall constitute an appropriation for the purposes stated of the sums therein set forth as appropriations, and authorization of the amount of \$4,298,928.22.

Revision of the Zoning Ordinance -

Attorney Clemack stated there are two open questions in regard to the revision of the zoning ordinance. The first question has to do with the animal ordinance. The second one is the Air B&B ordinance, which does not need to be in the zoning ordinance, but should be a separate ordinance, under a police ordinance. The council needs to discuss the guidelines they wish to set for Air B&B requirements in the borough. These two portions will be looked over and discussed by council for the next meeting.

Attorney Clemack read the resolution to allow the council to enter into executive session for the matter of discussion on Appointment of Hearing Officer – Police Disciplinary Matters – RFP. A

motion was made by Councilmember Law, seconded by Councilmember Haig, to enter into executive session for the matter of discussion Appointment of Hearing Officer – Police Disciplinary Matters – RFP. All were in favor.

Mayor Krasnomowitz explained the ordinance, for the borough, had higher standards than required by the state of New Jersey for food handling licensing. A motion made by Councilmember Law, seconded by Councilmember Endres to Introduce Ordinance 10-2024: Rescind Chapter 277 – Food Service Manage Certification. All were in favor. Adoption and second reading will be at the June 3, 2024 meeting of the Mayor and Council of the Borough of Hamburg.

Motion by Councilmember Law, seconded by Councilmember Burd to accept the Consent Agenda as presented. All were in favor.

COMMITTEE REPORTS:

COUNCILMEMBER BURD:

Councilmember Burd reported the Hamburg School had an increase in their budget of 2.35%. The Hamburg School lost \$171,000 in school aid. Councilmember Burd explained schools are rated on diversity and income. Across the area there was variety of increase and decreases. Hamburg had a 12%, Hardyston had a 7%, Ogdensburg had a 10%, and Franklin had a 29%.

Councilmember Burd explained the Borough decided not to go with a human resource outside company and to keep everything in house.

Councilmember Burd read a portion of Doreen Schott's retirement letter. A motion was made by Councilmember Burd, seconded by Councilmember Law to accept Doreen Schott's letter of retirement, with great regret. All were in favor.

COUNCILMEMBER OEHLER:

No report as Councilmember Oehler was absent.

COUNCILMEMBER ENDRES:

Councilmember Endres thanked Doreen for everything she has done for the Borough and expressed how much she will be missed.

COUNCILMEMBER LAW:

Thanked Doreen for all her work with the Borough and wished her well in her retirement.

A motion was made by Councilmember Law, seconded by Councilmember Haig to open the floor to Chief of Police, Jason Tangorra. All were in favor

Chief Tangorra explained the month of April was very busy for the police department, being they had the Distracted Driver Grant. He read the monthly report into the record. He explained the different trainings the officers and administrative assistant took through out the month of April. Chief Tangorra explained they have applied for another grant for Crossing Guards. Councilmember Law explained Car #6 has a bad transmission and a discussion needs to happen about weather or not to put money into it or to get rid of it and to purchase a new one. Councilmember Law explained the Crown Victoria will be put up for auction on Municibid.

COUNCILMEMBER HAIG:

A motion was made by Councilmember Haig, seconded by Councilmember Law to open the floor to OEM Coordinator Keith Sukennikoff. All were in favor.

Resolution 2024-50- Termination of agreement- Saint Clare's Health

Councilmember Haig, OEM Coordinator and committee have met with Atlantic Health and are proposing to enter into contract with Atlantic Health. Borough of Hamburg would be considered a central hub for Atlantic Health, with an ambulance always on site. During discussions response times, sprinter vans will be used so no power is needed. They would be housed in the OEM building. The committee saw no draw back with going with Atlantic Health. Attorney Clemack advises prior to moving forward he would require a signed contract from Atlantic Health. Upon discussion Mayor Krasnomowitz and councilmembers agree. A motion was made by Councilmember Law, seconded by Councilmember Sena to table Resolution 2024-50- Termination of agreement- Saint Clare's Health. All were in favor.

A motion by Councilmember Haig, seconded by Councilmember Law, to close the floor to the Chief of Police and OEM Coordinator. All were in favor.

Hamburg Municipal Building Lighting Estimate:

A motion By Councilmember Haig, seconded by Councilmember Law, to open the floor to the DPW Supervisor Alec Yanish. All were in favor.

Councilmember Haig explained multiple companies were reached out to for quotes to upgrade the lighting fixtures in borough hall. The only company who responded was JEM Electric for a total of \$6580.00. DPW Supervisor explained the quote covers putting 18 high hats in the meeting room, to replace the fixtures in the offices and hallway, and in the bathroom. Councilmember Sena questioned why the ballasts in the current fixtures wouldn't just be changed. DPW Supervisor explained there is real no savings and the high hats will look nicer and cleaner. A motion was made by Councilmember Law, seconded by Councilmember Burd to accept the quote to replace the lighting in the municipal building from JEM Electric in the amount of \$6580.00. All were in favor.

Councilmember Haig explained he received a quote from Shane Services LLC for \$700 to power wash the building two times. A motion was made by Councilmember Haig, seconded by Councilmember Law to accept the quote from Shane Services LLC of \$700 to power wash the building two times. All were in favor.

Pickleball Court /Basketball Court Improvement Project – Change Order Superior Play Systems: Councilmember Haig explained the Borough has allocated \$8000 to cover the cost of the nets and hoops for the pickleball court / basketball court project. Superior Play Systems quoted the borough \$7735.50 to put up the fence. A motion was made by Councilmember Law, seconded by Councilmember Haig to accept the change order and grant permission to Superior Play Systems to put the fence up for a total of \$7735.50. All were in favor.

COUNCILMEMBER SENA:

Resolution T2024-005 – Water/Sewer Overpayment Block 11, Lot 30 C0011 A motion was made by Councilmember Sena, seconded by Councilmember Law to accept Resolution T2024-005. All were in favor.

Delinquent Animal Licenses

A discussion was had about delinquent animal licenses. Summons may be issued to residents who have delinquent animal licenses.

Councilmember Haig explained his plan to continue to make the borough hall more presentable. He will be getting quotes for new doors and shutters.

PUBLIC PORTION:

A motion by Councilmember Law, seconded by Councilmember Haig to open the meeting to the public. All in favor.

A resident expressed her concerns about the amount of water running through her property. She has been attempting to sell this property, but has been unsuccessful due to the water issue. She explained she believes the borough is dumping stormwater into her property for discharge. She is asking for help with this issue from the borough.

A motion by Councilmember Sena, seconded by Councilmember Law to close the meeting to the public. All in favor.

Attorney Clemack stated a resolution for RFPs for appointment of Hearing Officer – Police Disciplinary Matters. The mayor and council authorized the hiring of Brian Aloia Esq. from Aloia Law Firm LLC as the Hearing Officer – Police Disciplinary Matters for a one-year appointment. A motion was made by Councilmember Law, seconded by Councilmember Endres to hire Brian Aloia Esq. from Aloia Law Firm LLC. as the Hearing Officer – Police Disciplinary Matters. All were in favor.
