ATTORNEY HOUR:

Attorney Clemack requested a motion to open the floor to CFO, Joseph Brezina regarding issues with Cintas. Motioned by Councilmember Haig, seconded by Councilmember Law. All in favor. Mr. Brezina stated we are seeking to terminate their contract. He was asked to clarify the issues and stated they are supposed to supply the DPW with clean uniforms, municipal buildings with clean mats, and cleaning supplies, on a weekly basis. Service is inconsistent, items billed but not received, uniform orders consistently incorrect and attempts to correct issues have been ongoing since their hire. Mr. Brezina stated the DPW is prepared to handle those responsibilities at a lower cost. Councilmember Sena wanted to verify the DPW workers would not be responsible for the cost of uniforms. Mayor Krasnomowitz stated the Borough would continue to provide uniforms for the DPW workers.

COMMITTEE REPORTS: COUNCILMEMBER BURD

There was no report at this time.

COUNCILMEMBER OEHLER

Councilmember Oehler reported Recreation will be looking for a better time of season for the Foot Golf event. Councilmember Oehler would like to establish online registrations for this event and possibly others. Councilmember Sena requested they investigate better forms of communications with the public.

Councilmember Oehler is working on reorganizing and cross training the committee to better serve the community. The Borough now holds a Costco card to be used for supplies for Council events at the request of the Recreation Commission. It may be used by any department or commission of the Borough.

Recreation Commission requested Councilmember Oehler present information recommending a Splash Pad for the Gingerbread Castle Road Park. Councilmember Sena noted funds from Open Space are not available. Mayor Krasnomowitz stated that due to the nature of the project it would be a Council decision.

COUNCILMEMBER ENDRES

Councilmember Endres stated a Quarry tour was held. There are still complaints regarding blasting but when investigated they still fall within acceptable parameters.

Councilmember Endres noted the Land Use Board will be meeting on October 14, 2024 with J. Caldwell to plan and discuss the state's affordable housing requirements.

COUNCILMEMBER LAW

Councilmember Law read the monthly fire department report into the record. Borough's Fire Department received a 2nd place trophy for trucks 1 to 6 years.

Councilmember Law read the monthly police department report into the record. New hire is on hold and vacant position still being advertised. New vehicle is almost completely fitted for service.

COUNCILMEMBER HAIG

Councilmember Haig noted the Borough now has a new exterminator, Howey Extermination Services, for all buildings. Company was changed to decrease expense. They are also a local company.

Atlantic Healthcare Ambulance Service is now servicing our area and are currently being housed in the Annex building and staff are parking in the Municipal Building parking lot.

Lights in the Municipal Building meeting room are going to be replaced with larger 8-inch pot lights for better illumination. The new lights for the remaining buildings were delivered and install will be scheduled.

Fall seasonal display has received a lot of compliments and they are preparing a Holiday display mid-November. They are also investigating use of a large antique bell owned by the Borough to

create a general display in that area by the wall. Colors would be matched to clock.

Three quotes have been received for security cameras for Borough parks. Attorney Clemack questioned if each park has been quoted as separate projects. The parks were quoted separately. Quotes for the newly finished Riverbank Park were being acquired when due to continuing incidents of vandalism at the Gingerbread Castle Road Park inadequacies in the security system made it necessary to acquire quotes for a new system. Councilmember Sena asked if warranties and service plans were included. Councilmember Haig stated he believed warranties did apply but was unsure as to the service contract. Attorney Clemack proposed the following resolutions regarding the security camera installation project for the Riverbank Park Courts and the Hamburg Recreation Fields.

Resolution 2024-82 Authorizing the award of contract to VP Security for camera installation – Riverside Park/Tennis Courts subject to Council approval of a service contract including satisfactory warranties.

COUNCILMEMBER SENA

Budget Committee has met and has started budget process for 2025. Reviewed routine items and costs. Road Department is in need of a new utility truck and that is under consideration. Police vehicles to replace older vehicles and a new vehicle for the Fire Chief are also under consideration. They will be scheduling another meeting to continue the planning process.
