APPROVAL OF MINUTES

Motion by Chris Fitzpatrick, seconded by Paula Marino to approve the minutes of January 15, 2013 Reorganization Meeting. All in favor.

Paula Marino had one correction – under Breakfast with Santa – the donation that was received went to the Recreation Commission, not to the Firehouse.

The ending balance is \$20,045.19. Members also reviewed the yearly report and found it to be helpful.

OLD BUSINESS / NEW BUSINESS

Family Fun Day

Tammy checked on holding Family Day in March or April at the YMCA. We are able to rent out the pool for 1½ hours for \$500.00 and have a room to serve snacks. Any child under the age of 6 must have an adult in the pool with them. Members say a Sunday would be better for them than a Saturday. Tammy will contact them again for a specific day so that we can get it in the newsletter for the residents.

Hamburg Day

Members discuss holding Hamburg Day this year on August 25th from 12 – 4 PM at the rec fields. More will be discussed.

Miss Hamburg, Little Mr. / Miss Hamburg Contests

Members discuss a date for the contests and decide on Saturday, June 15th, beginning at 2 PM, pending availability of the school, which Lisa will check on. Tammy will chair the event, Joyce will get the tiaras, and Chris will be the emcee, prepare the script, and acquire the judges. He will also ask his son Brandon to supply the background music on his guitar.

Summer Rec

Lisa discusses with members holding rec for only two weeks this year instead of three. Since the ordinance only lists the fee amount, and not a time frame, there would not be a problem changing this. Joyce will ask the Fire Dept. for the use of the pavilion from July 15^{th} - 26^{th} between the hours of 9 AM - 12 Noon. It will be put in the newsletter with these dates, along with the fee schedule of \$75.00 for the 1^{st} child, \$75.00 for the 2^{nd} child, and \$60.00 for each additional child of the same family. More will be discussed.

Wellness Lecture/Promotional Clinics

Chris has not contacted Brielle Senske about the wellness lectures and she has made no contact either. Board members are in receipt of an email from Cissy Gianelanella regarding her promotion of Hamburg Day. She stated that she did not realize the distance of Hamburg from her hometown and because of that, it would be very inconvenient for her and her staff to promote the event. Chris did not send a reminder to Garrett Goldsberry, with the Martial Arts Clinic, and he did not contact Chris either. Chris again stated that he found that adults have little interest in the clinics.

Paula brings to the members' attention that she would like to recognize Josh Abrahams with a special award for his involvement with the rec commission throughout the past year. He helped clean out the shed, he was very helpful at the Breakfast with Santa, being there at 7AM, and at various other functions he has been involved with, going overboard with helping. After discussion, motion by Paula Marino, seconded by Chris Fitzpatrick to give Josh Abrahams a \$75.00 Visa Gift Card and certificate as a volunteer award. Roll Call vote showed all members present in favor. Lisa Abrahams abstained.

Recreation gives a monetary donation each year to the Fire Dept. Auxiliary for the Easter luncheon. Motion by Chris Fitzpatrick, seconded by Tammy DeOliveria to give \$200.00 to the Fire Dept. Auxiliary for the Easter luncheon. All in favor.
