#### Clinics

Chris updated the board regarding the clinics: crafts – attended by 40 plus kids and he also had parents stay and help; juggling had 24; haz mat was cancelled as it was to be held at the ballfield which was snow covered, and since it had to be held outside, that day it was also raining. Chris will schedule this for September. Clinics coming up are mural arts, beading, and train safety, which will end the clinics for the year.

## Family Swim Fun - March 11th

There were approximately 35 adults and kids in attendance. Those that did attend had a terrific time and enjoyed themselves. Rec will have to look at this activity next year as to whether to hold it or cancel. They will also try to see if there are other activities going on at the same time that parents would not have to choose which to attend.

## Skate event - April 19th

Flyers went out through the school 2-3 weeks ago and there has not been any response yet, although it is early. Kathy spoke with Skylands and they do not want Rec to cancel the event. If 50 people attend, Rec will have private ice time. Should the number fall short, Rec will only be required to account for payment for the amount of skaters present but will not have private ice time.
