## Hamburg Day - August 24th

Chair Villagomez started by thanking everyone for making the event such a success. There was a count of 855 attendees. He would like to see it grow more next year. Council Liaison Oehler and Chair Villagomez agreed the roadside signage helped. Commission Member Weiss was thanked for obtaining the band for the event. Chair Villagomez also stated a better exit strategy at the end of the day is needed.

### Footgolf - September 12th

Vice Chair Walton stated he had not had a lot of time to promote the event but everyone in attendance had a great time. Approximately ten in attendance. He noted the local coaches stated a later time would work better as most of their players do not get off their school buses until almost 4:30pm. Vice Chair Walton suggested a later start time and /or a change in season for the event might help attendance.

# Trunk or Treat - October 26th

Secretary Stephens noted the flyers went out this week with Borough water bills. Some slight changse this year registering trunks for the event instead of attendees and moving the event away from the parking lot. Cars participating will now be parked along the path edge down below. Change has been suggested due to concerns with latecomers driving in the lot when children are present. Council Liaison Oehler was concerned there would be less treats as some cars do not decorate. Chair Villagomez stated any car dispensing treats would be down at the path.
