APPROVAL OF MINUTES

September 16, 2025 Regular Meeting Minutes

Motion by Vice Chair Art Walton, seconded by Commission Member Fran Weiss to approve the September 16, 2025 Regular Meeting Minutes. All in favor.

FINANCE

Members of the Commission discussed funds encumbered for remaining events.

Motion by Vice Chair Walton, seconded by Commission Member Weiss to approve the financial reports. All in favor.

OLD BUSINESS / NEW BUSINESS

Trunk or Treat - October 26th

Chair Villagomez noted recreation members will start setting up at 11:30 am, cars being set up on the lower field by 12:00 pm. He noted that they will be directing traffic into the spots along the path. Secretary Titka shared that there may be a time conflict due to an incoming soccer game at 2:00 pm. Chair Villagomez assured everyone would be out without issue of overlap. Best trunk prizes were confirmed: \$50 Quarry Grill gift certificate for 1st, \$30 Weiss gift certificate for 2nd, and \$25 TJs pizza gift certificate for 3rd. Vice Chair Walton donated 3 Four-person Footgolf gift certificates for the winners of cutest, scariest, and most original costumes. Council Liaison Oehler will be going to Dairy Swirl to request a donation to add to the costume prizes. Vice Chair Walton can not attend the event, requested the Mayor be asked to judge the trunk and costume competitions.

Halloween Decorating - October 15th-31st

Chair Villagomez noted the receipt of Commission Member Weiss's submissions for best houses, and encouraged everyone to go around thru the 31st to potentially add to their list. He also encouraged members to go during the day as well to better see all of the decorations, not just the ones that are lit up. Prizes confirmed as \$75, \$50, and \$25 for best houses. Winners must come pick up their prizes at the meeting to ensure delivery of prizes.

Breakfast with Santa - December 13th

Chair Villagomez reminded everyone of set up time the night before at 7:00 pm. Council Liaison Oehler noted that she has 3 cooks prepared for that day, to prepare the pancakes and sausage. With the added hands, the doors will open at 8:45 am, with breakfast served at 9:00 am. Attendance registration is due by December 8th for final head count for food. Council Liaison Oehler noted she will be ordering the cookies for both the tree lighting and the breakfast from Vo-Tech. COUNCIL LIAISON

Council Liaison Oehler stated that the council loved the idea of the Family and Senior Game Nights, adding the idea of a Trivia Night. Chairperson Villagomez loved the idea for a date in January/Febuary to fight off the winter blues. Recreation would provide games, chips, and water. Motion by Commission Member Weiss, seconded by Vice Chair Walton to set the date for Family Game Night for February 20th, 2026. All in favor.

Council Liaison Oehler also recommended adding pictionary or charades to the Ice Cream Social event in the future, replacing the need for Tom Gardner for entertainment. Everyone liked the idea of saving on the cost, but wanted to see how the game nights in the winter/spring did before making a decision.
