

AN ORDINANCE AMENDING CHAPTER 203 –VEHICLES & TRAFFIC - OF THE CODE OF THE BOROUGH OF HAMBURG PROVIDING FOR ADDITIONAL NO PARKING AREAS AND ADDITIONAL REGULATIONS

Ordinance #13-2011

BE IT ORDAINED, by the Mayor and Council of the Borough of Hamburg, in the County of Sussex, State of New Jersey, that Chapter 203 – VEHICLES & TRAFFIC- Section 203-8A Time-Limit Parking of the Code of the Borough of Hamburg, is hereby amended as follows:

1. Section 203 – 8A - Time-Limit Parking
 - A. No person shall park a vehicle between 2:00 am and 6:00 am on the East side of Orchard Street between Route 94 and Main Street on any Monday, Wednesday, or Friday.
 - B. No person shall park a vehicle between 2:00 am and 6:00 am on the West side of Orchard Street between Route 94 and Main Street on any Tuesday, Thursday, or Saturday.
 - C. No person shall park a vehicle at any time on either side of Main Street between Route 94 and Route 23, except in Designated parking spaces and commercial vehicles shall not park for more than 30 consecutive minutes in the said parking spaces.
 - D. No person shall park a vehicle on any municipal parking lot between the hours of 2:00 am and 6:00 am.
2. If any of this Ordinance is deemed or declared invalid for whatsoever reason by a Court of competent jurisdiction, the remainder of the ordinance shall remain in full force and effect.
4. This Ordinance shall take effect upon passage and publication as provided by law.
