

**ORDINANCE FIXING THE SALARIES OF CERTAIN OFFICIALS, OFFICERS
AND EMPLOYEES OF THE BOROUGH OF HAMBURG, COUNTY OF
SUSSEX, STATE OF NEW JERSEY**

ORDINANCE #02-2017

BE IT RESOLVED, by the Mayor and Council of the Borough of Hamburg, County of Sussex and State of New Jersey, as follows:
