

**BOROUGH OF HAMBURG
ORDINANCE #09-2018**

AN ORDINANCE PROVIDING AND DETERMINING THE RATE OF
COMPENSATION FOR OFFICERS OF THE POLICE DEPARTMENT OF THE
BOROUGH OF HAMBURG.

BE IT ORDAINED by the Mayor and Council of the Borough of Hamburg, County of Sussex and State of New Jersey, as follows:

Section 1. The base salary for **Sergeants** and **Patrol Officers** of the Police Department of the Borough of Hamburg, for the period January 01, 2018 through December 31, 2022 shall be as set forth on Schedule "A" attached hereto and shall be effective as of January 01, 2018.

Section 2. The base salary for the rank of **Lieutenant** for the period January 01, 2018 through December 31, 2022, shall be as set forth on Schedule B attached hereto and shall be effective as of January 01, 2018.

Section 3. All ordinances, or parts of Ordinance heretofore enacted which are inconsistent with any provision of this Ordinance, to the extent of such inconsistency, are hereby repealed.

Section 4. If any section or part of this Ordinance shall be declared to be unconstitutional or invalid, in whole or in part, by a Court of competent jurisdiction, such section or part shall, by the extent that it is valid, remain in full force and effect and no such determination shall be deemed to invalidate the remaining section or parts of this Ordinance.

Section 5. This Ordinance shall take effect upon passage and publication as provided law.
