## BOROUGH OF HAMBURG ORDINANCE #10-2019

AN ORDINANCE AMENDING CHAPTER 70-3G - CAT LICENSING SCHEDULE AND CHAPTER 70-8A - DOG LICENSING FEES - OF THE CODE OF THE BOROUGH OF HAMBURG TO PROVIDE FOR AN INCREASE IN FEES..

BE IT ORDAINED by the Mayor and Council of the Borough of Hamburg, County of Sussex, State of New Jersey that the aforementioned Chapters are hereby amended as follows:

- 1. Chapter 70-3G License Fee Schedule. Commencing January 01, 2020, a license shall be issued after payment of the fee of \$15.00 for each un-neutered cat and \$12.00 for each neutered cat. Commencing January 01, 2021, a license fee shall be issued after payment of a fee of \$19.00 for each un-neutered cat and \$16.00 for each neutered cat. All the remaining provisions of this subsection 3G shall remain in full force and effect.
- 2. Chapter 70-8A License Fee Schedule. Commencing January 01, 2020, a license shall be issued after payment of the fee of \$15.00 for each un-neutered dog and \$12.00 for each neutered dog. Commencing January 01, 2021, a license fee shall be issued after payment of a fee of \$19.00 for each un-neutered dog and \$16.00 for each neutered dog. All the remaining provisions of this subsection 8A shall remain in full force and effect.
- 3. In the event any part of or provision of this ordinance is deemed illegal or void by a court of competent jurisdiction, then in that event the rest and remainder shall remain in full force and effect.
  - 4. This ordinance shall take effect upon final passage and publication as provided by law.
