

**AN ORDINANCE AMENDING ARTICLE II, SNOW AND ICE REMOVAL, OF  
CHAPTER 183, STREETS AND ROADS, OF THE GENERAL CODE OF THE  
BOROUGH OF HAMBURG COUNTY OF SUSSEX, STATE OF NEW JERSEY TO  
AUTHORIZE THE IMPOSITION OF A LIEN ON PROPERTY FOR FAILURE TO  
TIMELY REMOVE ICE AND SNOW.**

**ORDINANCE 05-2026**

BE IT ORDAINED BY THE Mayor and Council of the Borough of Hamburg, County of Sussex, State of New Jersey, as follows:

1. Article II Snow and Ice Removal of Chapter 183 Streets and Roads of the General Code of the Borough of Hamburg is hereby amended to provide for a new Subsection designated as 183-17 **Removal by Borough; Cost**, which shall provide as follows:

In the event there is a failure to comply with the provisions of 183-14 hereof, such snow, ice or sleet may be removed by and under the direction of the Superintendent of Public Works. The cost of such removal shall be certified to the Mayor and Council, who shall examine such certificate of cost and, if it finds said certificate to be correct and reasonable, shall cause such cost to be charged against the lands and premises abutting upon the sidewalk or temporary sidewalk involved. The amount so charged shall thereupon become a lien and tax upon said lands and premises and shall be added to and be a part of the taxes next to be levied and assessed thereon and enforced and collected by the Tax Collector of the Borough of Hamburg, with interest.

2. In the event any part or portion of this ordinance is declared invalid by a court of competent jurisdiction, the rest and remainder shall remain in full force and effect.
3. Any ordinance or part thereof inconsistent with any provision of this ordinance is hereby repealed.
4. This ordinance shall take effect upon passage and publication as provided by law.

**CERTIFICATION**

NOTICE is hereby given that the above ordinance was introduced and passed on first reading of a meeting of the Mayor and Council of the Borough of Hamburg, held on Monday, March 2, 2026 at 7 p.m. and will be considered for a final passage at a regular meeting of the Mayor and Council to be held on Monday, April 6, 2026 at 7 p.m. or as soon thereafter as same can be considered, in the Municipal Building, 16 Wallkill Avenue, Hamburg, New Jersey at which time and place all persons interested therein or affected thereby will be given an opportunity to be heard concerning the same. A copy of said Ordinance is on file in the Office of the Borough Clerk, Municipal Building, 16 Wallkill Avenue, Hamburg, New Jersey and is available for public inspection during regular business hours. During the week prior and up to the time of public hearing, copies of said Ordinance will be available to the member of the general public who request the same.
