ORDINANCE NO. 11-2026

ORDINANCE OF THE BOROUGH OF HAMBURG, COUNTY OF SUSSEX AND STATE OF NEW JERSEY SUPPLEMENTING AND AMENDING CHAPTERS 164 AND 209 OF THE CODE OF THE BOROUGH OF HAMBURG INCREASING WATER AND SEWER CHARGES

BE IT ORDAINED by the Mayor and Council of the Borough of Hamburg, Sussex County, State of New Jersey, that Chapter 164 entitled “Sewers,” and Chapter 209 entitled “Water,” of the Code of the Borough of Hamburg are hereby supplemented and amended as follows:

Section I

The Code of the Borough of Hamburg, Section 164-69 entitled “Connection Charges,” shall be supplemented and amended as follows:

Pursuant to Section 164-69, shall reflect the following charge:

<u>Code Section</u>	<u>Description</u>	<u>Charge</u>
§164-69	Charge for sewer connection to Existing sewer line, per EDU	\$8,000

Section II

The Code of the Borough of Hamburg, Section 209-4 entitled “Installation of service connection and lines,” shall be supplemented and amended as follows:

Pursuant to Section 209-4, shall reflect the following charge:

<u>Code Section</u>	<u>Description</u>	<u>Charge</u>
§209-4	Charge for water connection to Existing line, per EDU	\$5,200

Section III

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

Section IV

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

Section V

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
